- Approve Regional Vendors from the HSEQW perspective logging approval/feedback on the SharePoint system.
- Provide monthly HSEQ statistics as directed by the Client.
- Feedback updates for HSEQ matters detailing Incidents, Front Foot activities, and High-Risk sites from the Region during weekly HSEQ Teams calls.

- Provide Internal Auditor direction and support on Regional Audits to maintain the internal audit schedule
